SYNOPSIS OF FACTS:

Subject organization reportedly directed by L. RON HUBBARD, sponsor of the Hubbard Dianetics Foundation, Wichita, Kansas, and purpose is ostensibly to unify science so public may be educated in use of scientific data for benefit rather than destruction of mankind. Board of Governors' names listed.

DETAILS: At Wichita, Kansas:

Confidential Informant I-1 a representative of an Agency of the Federal Government handling personnel and intelligence investigations, advised that he interviewed JOHN W. MALONEY, Business Manager for the Hubbard Dianetics Foundation, Inc., 211 West Douglas Street, Wichita, Kansas, regarding subject organization and MALONEY advised as follows:

The Allied Scientists of the World is an organization sponsored entirely by the Hubbard Dianetics Foundation and LAFAYETTE R. HUBBARD of Wichita, Kansas, also known as L. RON HUBBARD, is the actual director of subject organization. HUBBARD's name was not associated directly with subject organization because it was believed that scientists would not readily accept the organization if HUBBARD's name was associated with it. Subject organization contemplates closing its operation in Denver, Colorado in the latter part of January, 1952 and would most probably move to Wichita. The ostensible purpose of the subject organization is to unify science so that the public may be educated in the use of scientific data for the benefit rather than the destruction of mankind.
